FINANCIAL GUARANTEES BEFORE FINANCIAL ENTITIES

They guarantee directly or indirectly the risks monetary before financial institutions.

- **Lending of investment:** operations of lending are guaranteed before financial institutions, destined to finance the managerial heritage.
- **Refunding:** operations of lending are guaranteed before financial institutions, destined for the restructuring of the bank liabilities of the business.
- **Circulating lending:** operations of lending are guaranteed, before financial institutions, destined to finance the needs of treasury of his company.
- **Leasing:** operations of leasing are guaranteed.
- **Credit policy:** it is guaranteed before financial institutions, the quantities arranged the credit up to the authorized limit, for which the above mentioned entity binds, inside the agreed limit, to put at the disposal of the client the requested amounts.

Aval linked to investment projects: ensuring legal and formal obligations to the public administrations and agencies related to new investment projects.

Final and interim bonds: guaranteed to governments, public agencies, private entities or individuals the performance of construction contracts, management or similar services or the obligations arising from the tender.

Advance payment of subsidies: are guaranteed legal and formal obligations to public administrations and agencies not related to new investment projects.
